

**CITY OF PARMA HEIGHTS  
INVITATION TO BID**

Pursuant to Ordinance No. 2020-28 passed on December 7, 2020, sealed bids will be received by the Director of Public Service of the City of Parma Heights, at 6281 Pearl Road, Parma Heights, Ohio 44130, until 11:00 a.m. on **February 11<sup>th</sup>, 2022** for the **NORTH CHURCH DRIVE RECONSTRUCTION PROJECT** in the City of Parma Heights, County of Cuyahoga and State of Ohio.

The work to be performed under this contract consists of the removal and replacement of approximately 480 feet of North Church Drive from the intersection of Tobik Trail to the approach slab of the Big Creek bridge. The existing pavement consisting of asphalt overlay on concrete will be replaced with new concrete pavement on new compacted aggregate base. New curb and underdrains are also included in the work.

Bids and complete Specifications may be procured at the office of Euthenics, Inc. 8235 Mohawk Drive, Strongsville, Ohio 44136. Bidders shall deposit the sum of \$75.00 for the bids and Specifications. This sum is non-refundable. Checks shall be made payable to Euthenics, Inc.

Each bid must be made upon the Proposal Form provided in the set of Specifications and must be accompanied by a Certified Check, Cashier's Check or Letter of Credit drawn on a solvent bank in Cuyahoga County in an amount equal to ten percent (10%) of the amount bid or a Bid Bond in the amount equal to one hundred percent (100%) of the amount bid as a guarantee that if said bid is accepted, a Contract will be entered into and Surety Bond satisfactory to said City in an amount equal to 100% of the total bid will be furnished. Checks shall be made payable to the City of Parma Heights, Ohio.

**There will be a mandatory pre-bid meeting held on Thursday, February 3<sup>rd</sup>, 2022, at 2:00 p.m. at the office of Euthenics, Inc., 8235 Mohawk Drive, Strongsville, Ohio 44136.**

A bidder/contractor will be deemed committed to the Department of Labor's goals and timetables for the Cleveland, Ohio areas as specified in the Notice of Requirements for Affirmative Action to ensure Equal Employment Opportunity Executive Order 11246 by submitting a properly signed bid.
