Arts at the Center is a juried arts and fine crafts show featuring artisans representing all mediums. Our sixth annual show will be located at St. Michael's Woodside (5025 East Mill Road, Broadview Heights, OH 44147). The event will have live musical entertainment and a variety of food stations.

Arts at the Center is an indoor venue. Booth space allows for an 8-foot table plus display. Check-in starts at 12 NOON on Friday, November 16, and set-up must be completed by 5:00 PM. Booths are expected to be open during the Friday night reception.

Enclosed you will find the official application and contract. When returning your application and contract, please include at least three photographs of current work, labeled with artist's name and medium. In addition, please include one photograph showing current booth display with work visible. Upon your acceptance into the show, you will receive a confirmation letter and will be asked to submit your \$125 booth fee at that time.

**Arts at the Center will be on Friday and Saturday, November 16 and 17, 2012.** Friday hours are 6:30 PM to 9:30 PM. Friday evening is an invitation-only reception. Saturday hours are 9:00 AM to 4:00 PM, free and open to the public. Overnight security will be provided on Friday; however, you are responsible for your items.

**- ARTISAN CONTRACT -**

*This Contract is between Parma Community General Hospital and the Arts at the Center Committee (hereinafter referred to as Arts at the Center) and the person whose name appears on the line below, hereinafter referred to as the Artist or Artisan.*

- 1)** Accepted Artist or Artisan is required to be on-site throughout the hours the Arts at the Center is open to the public.
- 2)** The Artist or Artisan agrees to display merchandise in a neat and attractive manner and to cover all tables neatly.
- 3)** Artist or Artisan may display work only in the media categories in which they are accepted, and it must be comparable to work shown in submitted photographs. It is Art at the Center's exclusive right to remove work that is inconsistent or deviates from the style or quality of the submitted photographs.
- 4)** Sharing a booth is not permitted. An Artist or Artisan may not assign this contract to another party or sublet any of his/her space to another. Community organizations will be reviewed on an individual basis.
- 5)** The Artist or Artisan is responsible for all items in his/her booth at all times. The Arts at the Center is not responsible for loss from theft, fire, wind, hail, rain, cold, heat, sunlight, accident, injury, or an Act of God.
- 6)** The Artist or Artisan is responsible for all sales and must collect and remit the necessary State and Local sales taxes for Cuyahoga County.
- 7)** No pets allowed, except service animals.

I hereby acknowledge that Parma Community General Hospital and the Arts at the Center Committee does not accept or assume responsibility or liability for any property damage, loss or physical injury to vendors, vendors' property and/or guests.
