PUBLIC NOTICE 3/31/14

On Monday, April 7th, 2014, at 7:00 AM and weather permitting, Perk Company, Inc. will resume work on Snow Rd to finalize the project by completing the remaining section of Snow Rd. from Eldon Dr. to Bavaria (including the intersection with Pearl Rd). Traffic on Snow Rd. will be reduced to one lane in each direction on the north half of Snow Rd. as pavement repairs and resurfacing occur on the south half of Snow Rd. Right turn and exclusive left turn lanes will be maintained except when pavement removal or repair is required. Work on Pearl Road will be done utilizing temporary zones in order to keep traffic delays to a minimum.

Message boards will be placed prior to zone implementation on Monday, April 7th, 2014 to inform the public of the forthcoming implementation and change in traffic pattern. You can expect additional notices as the project progresses.
