SPEED

(1) \$3.00 per mile over the speed limit. COURT APPEARANCE REQUIRED IF THIRD OFFENSE IS WITHIN THE LAST TWELVE (12) MONTHS.	
(2) School Zone – \$4.00 per mile over the speed limit, COURT APPEARANCE REQUIRED IF THIRD OFFENSE IS WITHIN THE LAST TWELVE (12) MONTHS.

(1) Failure to Yield Right of Way	\$50.00
(2) Following too Closely	\$50.00
(3) Improper Turn, Improper Passing, Improper Lane Usage	\$50.00
